



Miss Cindy's Doodles Puppy Deposit and Reservation Agreement

This agreement (*Agreement*), dated _____ (**Effective Date**), is between **Miss Cindy's Doodles (Breeder)** and _____ (**Buyer**). The subject of this *Agreement* is for the below-described *Puppy or Litter* and the obligations defined herein.

The Breeder and Buyer agree as follows:

1. **Deposit.** A deposit of \$500 shall be due and paid to Breeder upon execution of this Agreement. This deposit shall be applied to the final Purchase Price of \$4,000.
 - a. Buyer acknowledges that the deposit is non-refundable with the following exceptions:
 - i. When the breeding does not result in pregnancy, Buyer may choose to either receive a full refund of the Deposit amount or maintain their same spot on the Waitlist for the next litter of the same or similar pairing.
2. **Reservation.** Upon receipt of deposit, Breeder will secure for Buyer either a) the next available spot on the Priority Waitlist from the above designated litter or b) an available puppy selected by Buyer from the above designated litter.
3. **Preferences.** If a puppy/dog that meets Buyer's identified preferences is not available when it becomes Buyer's turn to pick a puppy/dog from the selected litter, Buyer may elect to have the Deposit transferred to the next litter **ONLY ONE** time. If puppy is not selected from next litter, the Buyer forfeits deposit.
4. **Purchase Price and Payment Schedule.** The full purchase price of \$4,000 is agreed upon by both parties and is divided into three payments:
 - a. **\$500 Deposit** is due upon signing the **Deposit and Reservation Agreement** to reserve a waitlist spot or specific available puppy.



- b. **\$1,500 Payment** is due by 30 days after the puppy is born.
 - c. **\$2,000 Final Payment** is due by the day the puppy/dog is transferred from the Breeder to the Buyer. All shipping and handling expenses are the responsibility of and shall be paid by Buyer.
 - d. All payments due under this Agreement shall be made in US Dollars and paid to Breeder via Payments through Good Dog, Cash or Zelle. (Personal checks are not accepted for final payment unless received 1 week prior to puppy pick up to allow for bank processing.)
5. **Puppy/Dog Purchase Agreement.** Both parties have read and agree to all elements of the **Miss Cindy's Doodles Puppy/Dog Purchase Agreement** and further agree to execute the Puppy/Dog Purchase Agreement within one week following the successful delivery of the litter.

IN WITNESS WHEREOF, Breeder and Buyer have executed this Agreement effective as of the Effective Date.
